

Conditions of use

The sustaining membership or membership of the GEEhW e.V. shall grant the user with a request the right to use the pass word protected area of the online database on the URL <http://www.db.historische-waffenkunde.de> (in the following referred to as "the database"). These conditions for use regulate the associated regulations.

**1. Access to the database**

- (a) After his application for membership has been approved the user will get access to the database for the same period of time.
- (b) Institutions will receive a personal license for two users.
- (c) Access is obtained via the Internet. By using his user name and password provided the user can obtain access to the protected area of the database. Unless otherwise agreed this access entitles the registered user to use the data on the online database.
- (d) The authorization to access the database will be sent to the user in writing.

**2. Rights and obligations of the user**

- (a) The user is obliged to keep his user name and password secret and prevent any misuse by third parties. Apart from this he also makes sure that all active users of his institute also maintain these obligations.
- (b) If the user obtains any information about misuse of the access data, he should inform the association immediately. The user is responsible for any misuse. In the case of any misuse, the association has the right to block access to the database.
- (c) The number of licensed users with access to the database is limited.

(d) Content downloaded from the database as well as exported or saved data, may be utilized by users for their own private purposes and may also be further processed. Giving the information to third parties is strictly prohibited (misuse). The rights of the user and any copyright on the data remain unaffected.

(e) The publication of any content of the database or from any data, that has been extracted by further processing of the content, for scientific or non-commercial purposes required the written consent of the association.

*(Note: The articles of association of GEEhW e.V. It is exactly for this purpose that the database has been designed. Because of the use of and copyright on the data in each case reproduction authorization must be obtained.)*

(f) Any commercial use or distribution of any content of the database or from any data, that has been extracted by further processing of the content, in particular the sales, rent, leasing or licensing of data, text or images or any further information from the database is not allowed.

### **3. Liability**

(a) GEEhW e.V. shall not be held liable for temporary interruptions to the online service caused by operational disruptions, due to Force Majeure, through disruptions from network providers or any other unpredictable circumstances.

(b) GEEhW e.V. shall not be held responsible for viruses or any other damage that occurs through the use of the database.

### **4. Data protection**

(a) GEEhW e.V. is entitled to save the inventory and user data of the user in a machine readable form. All data is handled with full confidentiality and will not be passed on to any third parties by the association.
